## Conditions of Contract


Please initial each line individually to accept terms and conditions.

- Management reserves the right to modify, alter, change or cancel reserved league start times in interest of business opportunities, needs and challenges without notice. Every attempt will be made to give proper notice of changes in the schedule due to outings and events INITIAL: SA
- In case of rainouts, the league may choose to add additional weeks to the end of league play. INITIAL: SA

- League players are responsible for arranging a sub for weeks they will miss. No league makeup rounds will be permitted. **INITIAL:** \_\_\_\_\_
- Per Commonwealth of Kentucky Law- No person shall be permitted to bring alcohol onto the property. **INITIAL:** \_\_\_\_\_
- No personal coolers are permitted. **INITIAL:** \_\_\_\_\_
- In case of threatening weather conditions, all league players must suspend play immediately and return to clubhouse. Upon clearing of such weather conditions as declared by the facility staff, all league play will resume at the position occupied at the time of the weather delay. **INITIAL:** \_\_\_\_\_
- A complete league roster must be turned in prior to league start. Included in this form must be player names, phone number, home address and email. **INITIAL:** \_\_\_\_\_
- All players must adhere to the pace of play guidelines set by Kenton County Golf Course which is 2 hours and 15 minutes maximum for 9 holes. Any failure to meet these guidelines will result in a written warning for the league and can result in suspension of league play. **INITIAL:** \_\_\_\_\_
